# PART 1: GENERAL INFORMATION & OVERVIEW

#### 1.1 Executive Summary

The UBC Centre for Teaching, Learning and Technology (CTLT) would like to use Mailchimp to send newsletters to faculty, staff and students. Mailchimp is a USA-hosted tool that is not compliant with FIPPA residency requirements, and is subject to express consent from individual users who wish to opt-into this service. Submission was required due to request by UBC Cybersecurity to ensure all internal newsletter tools are compliant and may be whitelisted for the UBC-wide external email banner requirements.

# 1.2 Description of the Program, System, Application, or Initiative Assessed

The Centre for Teaching, Learning and Technology was previously approved for Phase 1 of the implementation of External Email Security Warning Tag. As part of Phase 2, we have been requested to submit a PIA. We use the email tool Mailchimp to send out newsletters (CTLT Dialogues Newsletter, CTLT Events Newsletter, CTLT Edubytes Newsletter, CTLT Digest (Internal) and the Institute of Scholarship of Teaching and Learning Newsletter) to those who subscribe to our newsletters. We use the following email addresses: edu.bytes@ubc.ca, ctlt.newslettter@ubc.ca and ctlt.isotl@ubc.ca. Our CTLT Indigenous Initiatives Team uses the Campayn Email Tool to send out their Indigenous Initiatives newsletter, using the email address bronte.burnette@ubc.ca.

#### **RISK CLASSIFICATION**

The inherent privacy risk classification level of this PIA submission is **4** - **High**. The residual risk classification level of this PIA submission at closure is **2** - **Low**.

The scope of this review is Mailchimp for use by CTLT, in the manner outlined within this PIA.

#### 1.4 Data Elements

Personal information collected includes: first name, last name and an email address. The email addresses are used to help send regular email newsletters related to teaching and learning at UBC.

#### 1.5 Storage or Access Outside of Canada (including back-ups and recovery)

Mailchimp servers are hosted outside of Canada and consent will be required to collect personal information and use the service.

#### 1.6 Data-Linking Initiative

This project is not considered a data linking initiative as contemplated under s.(36) of FIPPA.

- Indigenous Initiatives UBC faculty & staff, students, the teaching & learning community at various postsecondary institutions, and Indigenous communities
- ISoTL The main target audience is faculty members interested in learning about and engaging with the Scholarship of Teaching and Learning (SoTL). Secondarily, our newsletter caters to educational developers and students supporting this line of work
